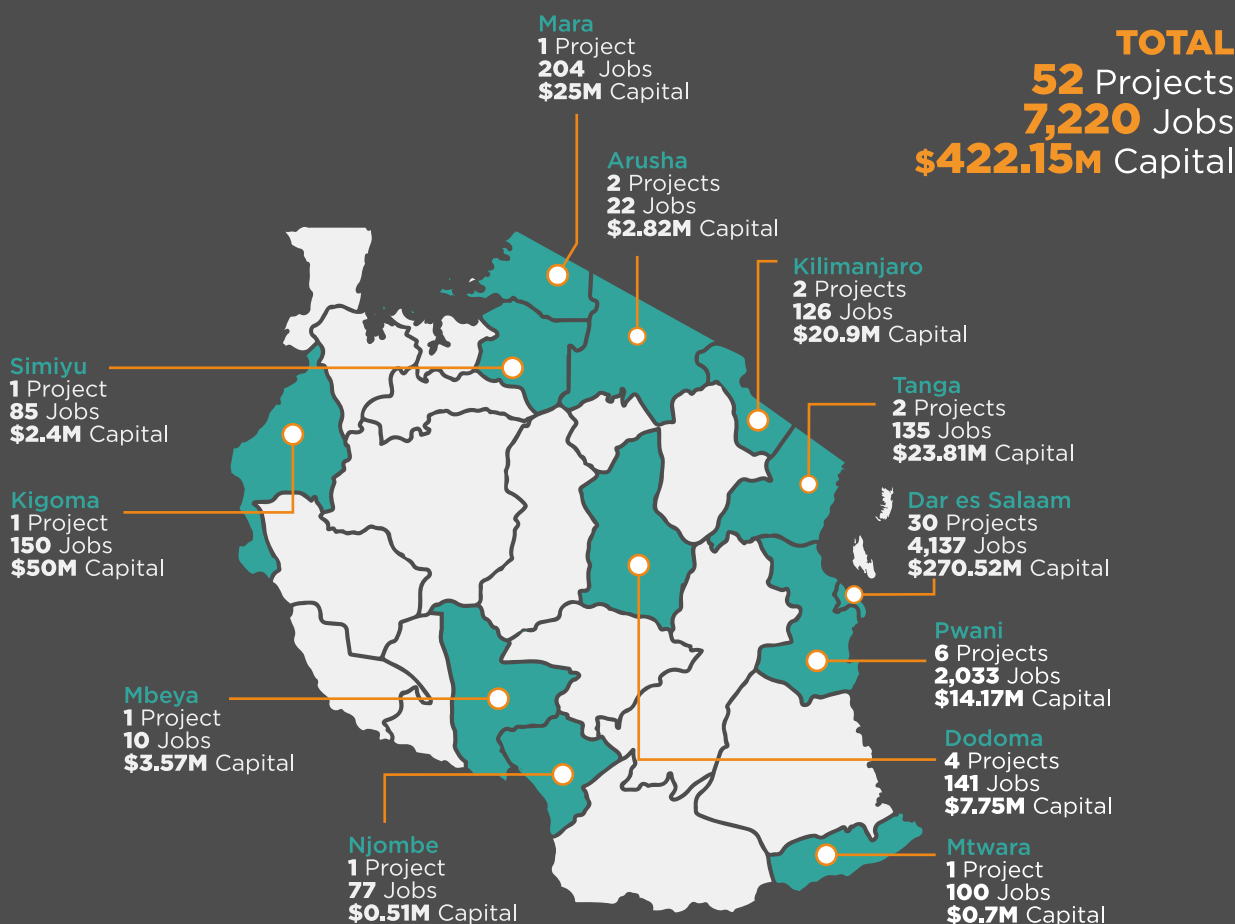

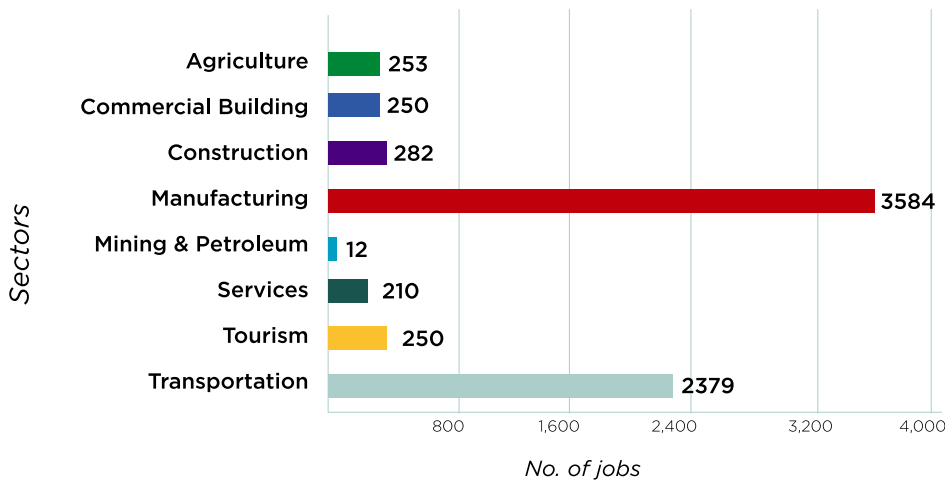

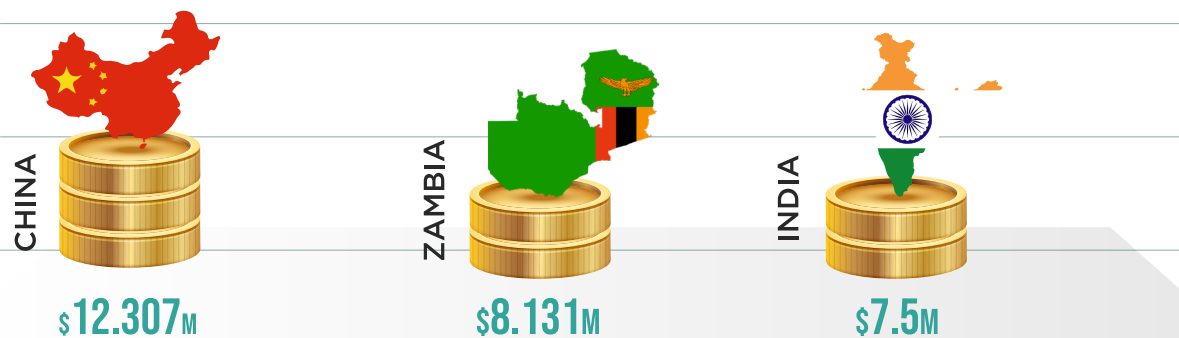

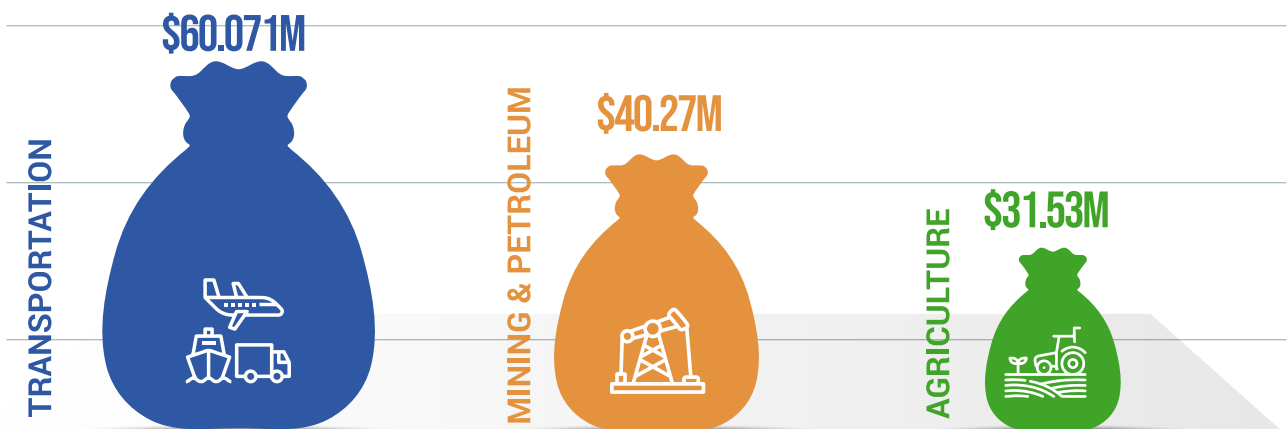

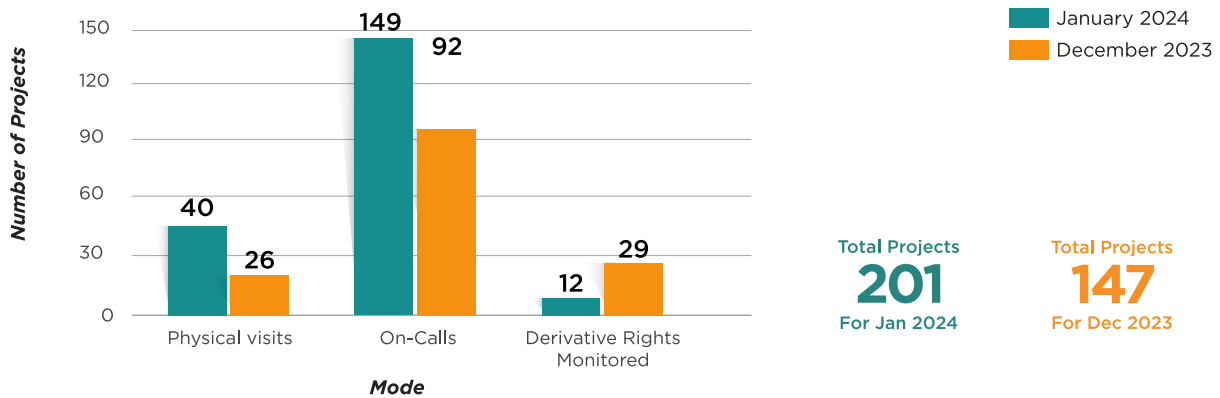




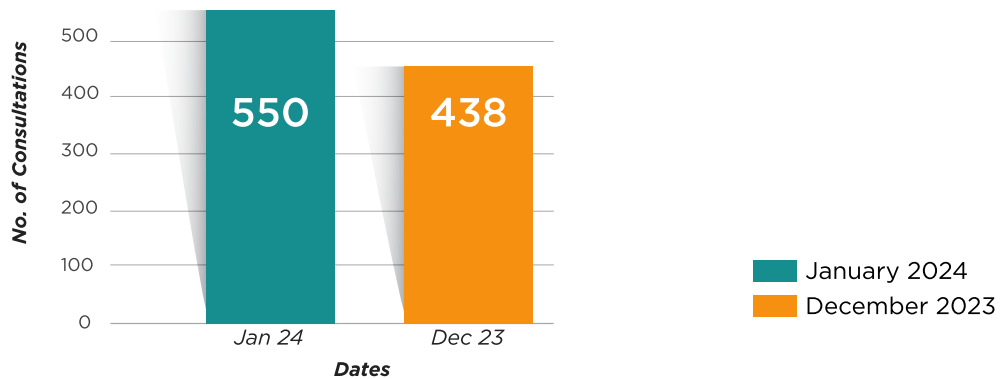
# NUMBER OF PERMITS, LICENSES AND APPROVALS ISSUED JANUARY 2024 AND DECEMBER 2023
